STARS REPORT: OHA agreed to fund the shortfall for the STARS project at almost 3 million. This was

welcome news as Director Anderson has been lobbying for this project for well

over a year now.

COLUMBIA TRUST UPDATE: Interest rates high, economy slow 2023-2024 hoping for a come-back in

2025.

Manufacturing and industry are in a recession. The federal fund rate is higher than

we have seen it this decade.

Strategy - continue to stay invested, US will recover faster than international,

growth and value funds are in the mix to help us stay positive.

**SNLH/SHS REPORT:**

SNLH and SPCH are now recognized as Stroke Gold Plus Hospitals. There are strict criteria on how to handle patients with stroke symptoms within 45 minutes they have scanned the patient and the radiologist has read the report and has a treatment plan ready.

Outpatient drive-thru pharmacy is in the works here at SNLH. It will be placed between the administration building and the Lincoln City Medical center parking lot where the old ambulance driveway is located. Hoping to have it completed by the end of the year.

SPCH will be getting a robot for surgery to help recruit new grads who have experience using robots. We hope to get one at SNLH soon.

ICU room supplies are finally in, and floors should be repaired in August.

NW Medical School in Lebanon will host a meet and greet August 1<sup>st</sup>,2023 and SHS will be present to recruit new graduates.

Operating – June numbers were up with a YTD 1.8 % above net operating margin.
